
- select suitable accounting policies and then apply them consistently;


Basis of opinion

1. **ACCOUNTING POLICIES**

Accounting Convention

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

The financial statements are in compliance with the Companies Act 1985 except that as described below the accounts are not consolidated and a cash flow has not been prepared.

Cash Flow Statement

The financial statements do not contain a cash flow statement as the company was dormant during the year. This is a departure from the Companies Act 1985 which requires a cash flow statement to be produced. As the company is dormant the directors are of the opinion that the cash flow would not provide any additional or meaningful information. The directors consider that this policy gives a true and fair view.

Consolidated Accounts

The financial statements have not been consolidated with that of its subsidiary as neither entity traded during the year. This is a departure from the Companies Act 1985 which requires consolidated accounts to be prepared. As both companies are dormant the directors are of the opinion that to consolidate would not provide any additional or meaningful information. The directors consider this policy to give a true and fair view.
