

The immediate parent company was Brand Addition Limited .The ultimate parent company was H.I.G Milan UK Topco Limited, a company incorporated in England. Copies of the Group financial statements can be obtained from its registered office at Brand Addition, Trafford Wharf Road, Trafford Park, Manchester, M17 1DD.

The directors consider H.I.G. Luxembourg Holdings Sixteen S.A.R.L to be the ultimate controlling party by virtue of their holding of 66% of the voting rights attached to the issued share capital of H.I.G. Milan UK Topco Limited. The remaining shares are held by other investors and management, none of whom individually control the company.
