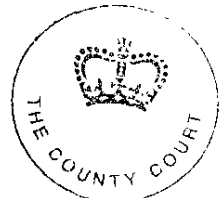
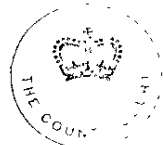
- (1) the name of the above named Hawkins Plant Services Limited be restored to the Register of Companies
