DIRECTORS' REPORT FOR YEAR ENDED 31ST MARCH 2012

The Directors present their annual report for the purposes for Section 45 of the Charities Act 1993 and Section 417 of the Companies Act 2006, together with the accounts for the year ended 31st March 2012. The directors have adopted the provisions of the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005, in preparing the annual report and financial statements of the charity.

STRUCTURE GOVERNANCE AND MANAGEMENT

Joint Council for the Welfare of Immigrants (JCWI) is a charitable company and is governed by a memorandum and articles of association agreed by its members and as approved by the Charity Commission and the Companies House. JCWI is governed by its Executive Committee (EC) acts as the Board of Directors of the charitable company. The EC meets regularly and as frequently as they wish and at least four times a year. The day-to-day operational management of the company is delegated to the Chief Executive.

Directors/trustees are selected on the basis of the contribution that they make to the governance of the organisation and the skills that they possess. They are made aware of the Charity Commission's guidance for trustees of a charity and are also given an introduction to the activities of the charity by the existing board. Directors/trustees are given training as and when required.

The directors have assessed the major risks to which the charity is exposed, in particular those relating to the specific operational areas of the charity and its finances. The directors believe that by monitoring reserve levels, by ensuring controls exist over key financial systems and by examining the operational and business risks faced by the charity, they have established effective systems to mitigate those risks

OBJECTIVES AND ACTIVITIES

JCWI is a high profile independent national charity which exists to provide direct legal representation to migrants and refugees and to promote justice, fairness and the elimination of discrimination in immigration, nationality and asylum law and policy. Its overarching objective is to relieve poverty and hardship amongst immigrants and refugees by promoting their human, economic and civil rights within an international human rights framework.

JCWI has a long (over 44 year) track record of undertaking challenging work that has had a significant impact on Government's policy in the sphere of its work. The organisation's strategies and priorities depend on the currency and importance of issues that affect migrants and refugees, and according to its capacity to deliver the work efficiently. Its current activities fall under four main areas.

- > Policy, information dissemination, media & campaign work,
- > legal advice and strategic casework,
- > training delivery ,
- > Publication of reference materials, guides and handbooks

ACHIEVEMENTS AND PERFORMANCE

Policy work JCWI remains a key campaigning voice and continues to argue for a more progressive approach to the development of British and European law and policy. The organisation's decisions during the year about what to focus on are driven by the views of migrants themselves, and the extent to which the government proposals engage human rights obligations and principles.

It continues to produce in depth briefings on the key policy areas which negatively impact on refugee and migrant rights. The following are a few builtet point examples of briefings produced by the organisation during the year.

- Briefing for parliamentarians on the transfer of judicial review provisions contained in the Crime and Courts Bill and attempted (all be it unsuccessfully) to use the passage of the Bill to raise the issue of access to the Court of Appeal and existing shortcomings through production of a parliamentary briefing on the 'second appeals test'
- · Responses to the Commission on a Bill of Rights discussion paper
- Briefing on the consultation on employment related settlement, Tier 5 and Domestic Workers, and the Government's consultation on the removal of the immigration reservation to the UN Convention on the Rights of Persons with Disabilities
- Briefing paper on the debate in the parliament about predicted population growth to 70million by preparing a well researched briefing on the issue
- · Briefed Parliamentarians against the removal of the full right of appeal for family visitors

JCWI's focus from earlier this year shifted to family union rights issues as the Government introduced new legislation, and a new set of extremely restrictive Immigration Rules governing family migration. Key changes in it are a new and far higher income/savings requirement for those seeking to sponsor non-EEA family members to join them in the UK, attempted limitation of the scope and application of Article 8 of the European Convention on Human Rights (right to respect for private and family life), an extension of the probationary period (temporary leave which limits access to the welfare state) for non-EEA spouses of British/settled people, and abolition of full rights of appeal for all family visitors by 2014. These changes sit in the context of the planned removal of legal aid for immigration cases in 2013. Their cumulative effect will be to create a far harder, longer and more precarious route for securing both entry to, and settlement in the UK for familial purposes.

On the family union issue JCWI published two well researched campaigning pamphlets, entitled *United By Love, Divided by Law*, for parliamentarians and activists. The first edition of the pamphlet focused on the proposed increase in the maintenance threshold and the probationary period, and the 'attachment' requirement for sponsorship of family members was published in the beginning of the year. The Government has now abandoned the attachment period. The second focused on the maintenance threshold.

Information Dissemination, Campaign and Media Work

JCWI's policy and campaigns work is supported and enhanced by high-quality information dissemination, mainly through our website, blog and through social media (primarily Facebook, Twitter and LinkedIn) Around 2/3 articles on salient issues both from internal and external contributors are posted on the blog each week and on average has a weekly readership of 3000

During the year JCWI has shown a strong growth in its media profile, both in traditional print and broadcast media and social media online. It has recently enjoyed appearances on Newsnight (BBC), Channel 4 News, ITN news, Islam channel and several ethnic TV and radio channels. Additionally frequently quotes from the organization appear in The Guardian, Independent and in other media outlets on salient issue. JCWI's first campaigning leaflet on the restrictive family union rules received extensive coverage in the Guardian and impacted more generally on the relatively sympathetic media narration of the issue, and its potential impacts.

In addition to the campaign against the Government's new family rules JCWI remains involved in regular asation irregular migrants campaign and *The I Migrants* campaign It has established a telephone advice line for irregular migrants with a view to collecting information regarding irregularity for planned publication of a report on this important issue in 2013/14

Strategic Advice and Casework

JCWI's a small but effective advice & casework team (comprising of 2 solicitors) continues to undertake strategic advice and casework. The team has developed a strong reputation in this field as it has conducted a number judicial review cases and achieved significant precedent setting results. Notable among these is the victory in the case of "Quila" before the Supreme Court which has had huge positive impact as it obliged the Government to change the Immigration. Rules regarding discriminatory marriage age of non-EU spouses and civil partners. This case alone will benefit estimated 5000 genuine couples a year. JCWI as a high profile organisation have also intervened in a few cases before the High Court in partnership with lawyers in private practice.

JCWI's relationship with UNISON has successfully been maintained as the legal team has provided advice and assistance to hundreds of very deserving union members, mainly working in the health and care sector. Additionally, the advice line for irregular migrants, mentioned above, will enable irregular migrants to access competent free legal advice and in many cases they will find legal avenues to regularise their status in the UK.

Training

Training remains a core area of JCWI's activities as it enables it to maintain a closer relationship with practitioners in the wider community as well as it generates income for the organisation. As one of the leading training providers in this field the organisation has delivered 63.

training courses spanning over 75 days in last year. These courses include in-house courses tailor made for trainees in respected organisations such as Welsh and Scottish Refugee. Councils

Publications

Guide to the Points-Based System, published in 2011, has been well received by users. This year work for an updated version of the main handbook, Immigration, Nationality and Refugee Law Handbook, has begun and it is expected that editing work on the book will be completed by the end of this year with a view to publishing it in early 2013. The organisation will continue to publish other reference materials and pamphlets.

Charitable fundraising

As an urgent priority during the year a number of funding applications were submitted to charitable funders in order to increase the organisation's income. It will be noted from the accounts that there has been some modest success in this respect. As always, the organisation will continue to seek funding from charitable sources.

Membership

JCWI's strength lies in its diverse membership base comprising of **304** voluntary and non-governmental organisations, around **70** legal practitioners and their practices and around **400** individual members. The organisation has always been striving to improve its membership service and during the year it has further improved its membership database and web-based information.

FINANCIAL REVIEW

The income and expenditure account for the year ended 31^{st} March 2012 is set out on page 9 it shows income of £525,963 and expenditure of £519,190. This has resulted in a surplus of £6,773 from which the amount of £6,000 has transferred to Reserves Funds

JCWI's self-generated income, from legal aid, training, publications and membership, amounted to £402,481 - 76% of the total income and Grant income from charitable trusts, foundations and donations was £123,482 - 24% of the total income A number of grants were given for the purpose as specified under the grant condition. Therefore, these are shown in the accounts as 'restricted funds'

The Immigrants' Aid Trust (IAT) continued to support the charitable work undertaken by JCWI by making grants totalling £30,000

All unrestricted funds have not been designated by the trustees for any specific purpose

The salaries and related staff costs were reduced by £32,701 to £269,128 and represent 52% of the total expenditure of £519,190. All other costs also increased by £91,181 to £250,062.

RESERVES POLICY

It is JCWI policy to aim to maintain a balance of $\mathfrak{L}90,000$ on unrestricted funds (if possible), which equates to at least three months cover for emergency situations that may arise from time to time. The balance at present is $\mathfrak{L}9,693$ held on unrestricted funds at the end of the year

RISK MANAGEMENT

The Trustees have overall responsibility for JCWI's system of internal control. Such a system of control can provide only reasonable, and not absolute, assurance against inappropriate or effective use of resources, or against the risk of errors or fraud. These risks are further heightened, given the difficult nature of institutional and financial infrastructure in respect of some policy and case work undertaken.

Additionally, the Trustees continue to assess the risks (as identified in the risk register)

The nature of some of JCWI's work requires acceptance of some risks which are outside JCWI's control, i.e. risk which cannot be eliminated or fully managed, but where this happens there is active and clear monitoring of the risk. The trustees consider that systems and controls are in place to monitor, manage, and mitigate JCWI's exposure to major risks. These include, among other control mechanisms, the maintaining of JCWI's general reserves at the levels stated above and the review of key systems and processes by the management

FUTURE PLANS

The directors will, adopt the following strategies to meet the budget of the organisation

- > Increase fundraising efforts from charitable sources
- > Revise membership strategy to increase the number of members and benefactors of the organisation
- > Assess income generation streams of the organisation to increase income from, for example, training, legal advice and assistance and the sale of publications
- > Retain and service the Legal Aid contract in order to be able to provide free legal advice and assistance to JCWI's clients and expand client base and income through this source
- > Adopt policies to cut costs from financially unproductive work
- > Increase the amount of reserve fund

The directors are confident that by adopting the above strategies, JCWI will be able to meet the budget of the organisation and put the organisation on sound financial footing by establishing a sufficient level of reserves over the course of future accounting periods

FINANCIAL MANAGEMENT

In order to enhance its finance and resources management JCWI will create a post of part-time Office Administrator with developed financial skills. This post holder will assist the Chief Executive in developing JCWI's finance and business development strategies in order to maximise the organisation's income. With the help of the post holder, the organisation will be able to create enhanced financial reporting on a regular basis for the Chief Executive and Board of Directors and all relevant external authorities and funders. JCWI will ensure that it has robust financial management systems, such as, timely production of financial reports on budgetary controls and management accounts, so that all sections of the organisation including the Board of Directors receive accurate and transparent financial information.

DIRECTORS' RESPONSIBILITIES

Company law requires the directors to prepare financial statements for each year which give a true and fair view of the state of the affairs of the company and of the profit and loss of the company for that period. In preparing those financial statements the directors are required to

- select suitable accounting policies and apply them consistently,
- b) make judgements and estimates that are reasonable and prudent,
- c) prepare the financial statements on a going concern basis unless it is inappropriate to presume that the company will continue in business

The directors are responsible for keeping adequate accounting records which disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as the directors are aware

- a) there is no relevant audit information of which the company's auditors are unaware, and
- b) they have taken all steps to make themselves aware of any relevant audit information and to establish that the auditors are aware of that information

1 ACCOUNTING POLICIES

(a) Scope and basis of the financial statements

The accounts have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and the Statement of Recommended Practice (SORP 2005) "Accounting and Reporting by Charities" and and applicable accounting standards published in March 2005

(b) Incoming Resources

All incoming resources are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. Income represents mainly monies from Trusts and Donors which supported JCWI in its work in the current financial year.

(c) Resources expended

Resources expended are included in the statement of financial activities on an accrual basis, exclusive of any VAT which can be recovered

(d) Fixed Assets

Depreciation has been provided to write off the cost of fixed assets on the following rates Computers Fixtures & Fittings - 20% Reducing Balance

(e) Stock and Work In Progress

These have been valued consistently by the directors at the lower of cost and net realisable value after making due allowance for obsolete and slow-moving stocks. Cost includes all direct costs and an appropriate proportion of fixed and variable overheads.

(f) Cash flow statement

The financial statements do not include a cash flow statement as the charity has taken advantage of the exemption from preparing such a statement that are available to smaller entities

(g) Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have been designated for other purposes

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or raised by the charity for particular purposes. The cost of raising and administering such funds is charged against the specific fund.

(h) Pensions

The company operates a defined contribution pension scheme. Contributions are charged to the income and expenditure account as they become payable in accordance with the rules of the scheme.
