JOINDER AGREEMENT dated as of [7 May 2000] (this "Joinder") by COBRA BIOLOGICS HOLDINGS LIMITED, a company incorporated in England and Wales with registered number 04442927 and COBRA BIOLOGICS LIMITED, a company incorporated in England and Wales with registered number 02710654 (each an "Additional Grantor" and, collectively, the "Additional Grantors"), in favor of CRG SERVICING LLC, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, the "Administrative Agent") for the benefit of the Secured Parties (as defined in the Security Agreement referred to below).

- A.
