

POWER OF ATTORNEY

- 1. - 1.3 generally to execute any deed or sign any document in his own name which may be required and to do any other act matter or thing which the Attorney shall consider necessary or expedient for carrying out any of the purposes or acts hereby authorised in the same manner and as fully and effectively in all respects as the Principal could have done if personally present;
- the Principal agrees to indemnify the Attorney against all expenses, losses and liabilities incurred by him when acting in pursuance of this power;
- 1.5 this Power of Attorney shall come into force at 0.00 on 3.10.13 and shall remain in force for 12 months expiring at 0.00 on 3.10.14;

 or agent appointed by him under the aforesaid powers shall do or purport to do by virtue of
 these presents.
- 3. THE PRINCIPAL hereby revokes any previous Power of Attorney and ratifies all acts carried out by the Attorney under the previous Power of Attorney.
