

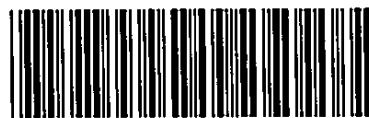



**7. ULTIMATE PARENT UNDERTAKING AND RELATED PARTY TRANSACTIONS**
