AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 30<sup>th</sup> June 2022

AND the Claimant undertaking that:



(A) the Company will not carry on business or operate in any way other than to take the necessary steps to:

(i) surrender the Leasehold interests in the following properties, situate at and known as:



(a) The Science and Technology Block, University of Derby,  
Kedleston Road, Derby Derbyshire registered with Her Majesty's  
Land Registry under Title Number DY248548

(b) The Business School, University of Derby, Kedleston Road,  
Derby, Derbyshire registered with Her Majesty's Land Registry  
under Title Number DY248549

(the Leasehold properties) referred to in paragraph 25.1 and 25.2  
of the Witness Statement of James Fussell dated the 19<sup>th</sup> May  
2022 (the Witness Statement)

(ii) record the satisfaction of Charges registered over the Leasehold  
properties referred to in paragraph 31.4 of the Witness Statement and

(iii) settle all outstanding debts to its existing creditors, if any;

(the actions) according to law

(B) it will notify the Registrar of Companies immediately on the conclusion  
of the actions

(C) the directors of the Company will immediately on the expiry of 3 months from the  
conclusion of the actions apply to the Registrar of Companies for the voluntary  
strike off of the Company under Section 1003 of the Companies Act 2006 and  
comply with all the relevant requirements for such an application

AND UPON the solicitors for the Claimant and the Registrar of Companies (the  
Defendant) both consenting to this Order



IT IS ORDERED that:

(1) the name of the above named Derby College Limited be restored to the  
Register of Companies

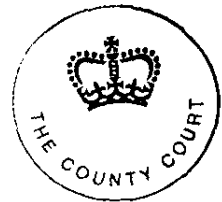
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 02722280 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
