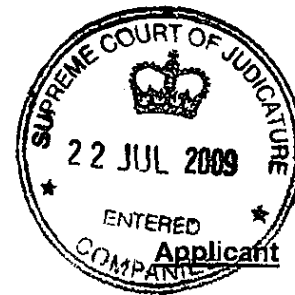

UPON the Application of Filippa Bjørg Connor by way of Ordinary Application Notice dated 30 June 2009

AND UPON reading the documents recorded on the Court file as having been read

IT IS ORDERED that:

1. In respect of the administrations particularised at Schedule A below an order that the Applicant be removed as administrator, and that the Respondent continue in office as sole administrator thereafter.



2. In respect of the administrations particularised at Schedule B below, an order that the Respondent be removed from office as joint administrator, and that the Applicant continue in office as sole administrator thereafter.
3. In respect of the compulsory liquidation particularised at Schedule C below, orders that:
 - 3.1. The Applicant be removed as liquidator; and
 - 3.2. The Respondent be appointed as liquidator in substitution for the Applicant.
4. In respect of the compulsory liquidation particularised at Schedule D below an order that the Applicant be removed as joint liquidator, and the Respondent do continue as office-holder and sole liquidator thereafter.
5. In respect of the creditors voluntary liquidations particularised at Schedule E below, orders pursuant to s108 and s171 Insolvency Act 1986 that:
 - 5.1. That the Applicant be removed as liquidator;
 - 5.2. That the Respondent be appointed as liquidator in substitution for the Applicant.
6. In respect of the creditors voluntary liquidations particularised at Schedule F below an order that the Applicant be removed as joint liquidator, and that the Respondent do continue as office-holder and liquidator thereafter.
7. In respect of the creditors voluntary liquidations particularised at Schedule G below an order that the Respondent be removed from office as joint liquidator, and that thereafter the Applicant do continue in office as sole liquidator.
8. Notice of this order, together with notice of the liberty to apply provision at paragraph 9 below, shall be given to all creditors of the estates listed in Schedules A – G inclusive in the next statutory report to the creditors of these estates.
9. There be liberty to each creditor in respect of each of the appointments particularised at Schedules A – G inclusive to apply to Court to vary or discharge this order insofar as it relates to an estate of which they are a creditor within 28 days of them receiving notice of the order made pursuant to the application herein.



10. There be no order as to costs.

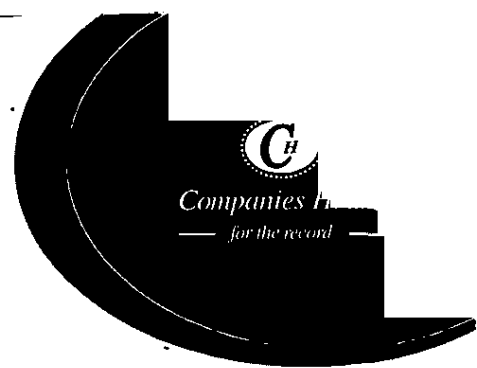
