REPORT OF THE AUDITORS TO THE DIRECTOR OF
ZEDCRAFT LIMITED
PURSUANT TO PARAGRAPH 24 OF SCHEDULE 8 TO THE COMPANIES ACT 1985

We have examined the abbreviated financial statements on pages four to six together with the full financial statements of ZEDCRAFT LIMITED for the year ended 30 June 1994. The scope of our work for the purpose of this report was limited to confirming that the company is entitled to the exemptions claimed in the statement of the director on page four and that the abbreviated financial statements have been properly prepared from the full financial statements.
