Notes to the financial statements

1. Directors' benefits: advances, credit and guarantees

Included within other creditors at the year end, is an amount of £1,635 (2015: £304) owed to N E V Martensson, director. The movement relates to business expenses paid for privately.

Included within other creditors at the year end, is an amount of £1,163 (2015: £327) owed to P N E Martensson, director. The movement relates to business expenses paid for privately of £824 (2015: £2,214), unpaid wages of £1,277 (2015: £nil), less expenses paid on behalf of the director of £955 (2015: £nil) and repayments to the director of £310 (2015: £232,204).

2. Related Party Transactions

Included within other debtors at the year end, is an amount of £611,335 (2015: £687,978) owed from IPR Property Limited, a subsidiary. The movement in the year relates to amounts loaned to IPR Property Limited of £21,203 (2015: £12,507) less amounts repaid of £97,846 (2015: £283,213).
