The Trustees submit their annual report and the financial statements of Westminster Arts for the year ended 31 March 2020 which have been prepared under the Companies Act 2006.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

Company law requires the Trustees, as directors, to prepare financial statements for each financial year that give a true and fair view of the state of the affairs of the charity and of the surplus or deficit for that period. In preparing those financial statements, the Trustees are required to:

- · Select suitable accounting policies and then apply them consistently;
- · Make judgements and estimates that are reasonable and prudent; and
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its activities.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity. They are responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

OBJECTS

Westminster Arts (now trading as Resonate Arts) is a company limited by guarantee. Originally it was a non-incorporated association founded as the City of Westminster Arts Council in 1965. The company is governed by its Articles of Association: it is a charity registered with the Charity Commission, number 1025755 and as such is a non-profit making organisation.

The Trustees undertook a review of its governance and strategy following Westminster City Council's decision in 2013 to discontinue its core funding and also a small grants programme that the charity delivered on their behalf since the foundation of our organisation in 1965.

This prompted a critical evaluation of the charity's position, and Westminster Arts' role has been reframed to build on its key strengths and track record around the development of projects and services that utilise the arts as a means of improving the health, wellbeing and quality of life of those socially excluded groups and individuals.

The principle focus of work now currently is to support people living with dementia and their families, supported in the main by the Central London and West London Clinical Commissioning Groups and a range of Trusts and Foundations and earned income/private giving. In response to the limitations of being able to provide services exclusively for beneficiaries that live, work or study in Westminster an EGM was held 26 March 2013, at which a special resolution was passed to amend the objects of Westminster Arts as follows:

"Westminster Arts is established to promote social inclusion with a particular focus on addressing the needs of those socially excluded by age, physical or mental disability (including dementia) through the development and delivery of arts based activities and experiences including but not limited to visual arts, photography, film, dance, music and drama."

This allowed the Charity to negotiate funding from the West London and Hammersmith & Fulham Clinical Commissioning Groups, which facilitated the establishment of the new roles of Resonate Projects Co-ordinator and, more recently, Projects Assistant/Administrator; plus, we decided to implement a working name change to befit our multi borough remit and decrease confusion for our participants.

TRUSTEES

The Trustees are responsible for providing overall policy direction, approval and oversight, to enable the programme-based and day-to-day planning, project creation, resourcing, execution and management of Westminster Arts activities by its staff. The Trustees are kept informed by staff and do not receive any remuneration for carrying out their responsibilities.

With effect from 26 June 2012, the members of Westminster Arts are persons ("the Trustees") who support the Company's objects and who have each guaranteed to contribute the sum of £1 in the event of the company being wound up.

The organisation has ended this period in deficit for the first time, due to a significantly decreased capacity to meet fund-raising targets following from the Director's ill health. This has been despite the Trustees' response to engage a fund-raiser whose work has since reaped benefits. Meaning that the issue of deficit is on track to being fully addressed in 2020/21.

The Trustees continue to have due regard to the Charity Commission's public benefit guidance when exercising their powers and duties in achieving the purpose of the charity.

In the year reported on the Trustees have continued to provide social and well-being benefits to people living with dementia in Kensington, Chelsea and Westminster and some of the public services they come into contact with, through three principal activities:

- 1. Creative Befrienders: volunteer artists who support the well-being of people living at home through the social opportunity of exploring and/or making art together.
- 2. Arts in the Community: running arts projects or experiences, in a variety of localities which provide conducive environments for people living with dementia to enjoy social contact with others. These projects ensure local opportunities for 'social prescription'.
- 3. Dementia Consultancy: supporting local health, social and arts organisations to understand and respond to dementia as a 'social disability' in order to build dementia friendly communities.

We fully met the delivery requirements and projects for the Charity's funders. Our outcomes are outlined in our Impact Report 2019 – 20.

In summary, we:

- Concluded work in Hammersmith and Fulham following withdrawal of support from their Clinical Commissioning Group for all dementia services.
- Worked with existing and new partners to provide projects in Westminster, Kensington and Chelsea. This work has been supported financially in partnerships with Victoria & Albert Museum, Carers Network, Science Museum and European Reminiscence Network.
- Participated in conferences to promote Social Prescribing and undertaken a service user consultation for the new Dementia Strategy in KCW.
- · Recruited a new Project Manager, Julie Foord, and promoted Emma Nutland to Project Manager.
- Supported the Director to reduce working hours and manage a long-term health condition, including recruiting external support for fund-raising and appointing an Honorary Treasurer.
- Updated the Charity's Reserve Policy in the light of staff changes.
- Developed a transitional plan for new leadership and review of the organisation's operations to allow the Director to leave for reasons of ill health.
- Articulated the need to newly evidence effectiveness in reducing social isolation; and review the operation of Creative Befrienders as a core service.

RESERVES POLICY

Westminster Arts aims to maintain a consistent level of provision for arts activities. In some years this means it has to draw on its unrestricted funds while in others it may add to these funds. In the year under review funds overall have decreased by £14,907, leaving unrestricted funds at 31 March 2020 of £57,280 (2019: £72,187). Unrestricted funds are in addition to restricted funds which were nil at 31 March 2020 and 31 March 2019.

CONTINUING OPERATIONS

The Company's future is dependent on identifying and securing new funding. There have been capacity challenges in reaching targets this year.

RISK REVIEW

The Trustees review the major risks to which the charity is exposed at each Board Meeting and a risk register is established to help check and mitigate these risks. The significant external risk in regard to the receipt of income assessed in 2018-19 continues into 2019-20 and has been monitored through improved budgetary forecasting and financial reporting led by the new Honorary Treasurer. The funding from the Clinical Commissioning Groups is not guaranteed from one year to the next and delays in contracting causes considerable uncertainty.

Internal risks are minimised by the implementation of procedures for the approval and authorisation of transactions and projects and to ensure consistent quality of delivery for all operational aspects of the charitable company. These procedures are periodically reviewed to ensure that they still meet the needs of the charity.

1 Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention.

The financial statements have also been prepared with reference to the guidelines set out in the Statement of Recommended Practice 'Accounting and Reporting by Charities: SORP FRS102' and the Companies Act 2006.

Fund accounting policy

Where Westminster Arts receives monies from sources where there is a requirement for those monies to be applied towards a particular project, these are treated as restricted. Otherwise funds received from other sources which carry no such obligation are treated as unrestricted funds.

Funds which are wholly attributable to specific charitable projects are classified as restricted.

The company incurs administrative costs to enable it to run multiple charitable projects.

Accordingly, unless a fund received is specifically restricted to direct project costs the company will allocate a proportion of all funds to overhead costs as described in Note 4 to the accounts.

All restricted funds are income funds.

incoming resources

Donations and other income are taken to the credit of the Statement of Financial Activities on a receivable basis. Incoming resources from tax reclaims are included in the statement of financial activities at the same time as the gift to which they relate.

Resources expended

Expenditure has been charged to the Statement of Financial Activities on an accrual basis inclusive of irrecoverable Value Added Tax.

Fixed assets

Tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. Depreciation is provided at rates calculated to write off the cost of the fixed assets, less their estimated residual value, over their expected useful lives on the following basis:
