The purpose of this meeting is being held to clarify the Company position resulting in the transfer of No.6 Southcliffe as follows:

- 1. Mrs.Julia Claxton the previous owner was the Treasurer and a Director of this Company. On the 12th May, 1995 this property transferred. On this day Mrs.Claxton ceased to be a Director.
- 2. From the 12th May, 1995 all accounting records were lodged with the Secretary Miss Margaret Turner 15 Southcliffe who has since replaced Mrs.Claxton as a Director and will also act as Treasurer until the Annual General Meeting scheduled for January, 1996.
