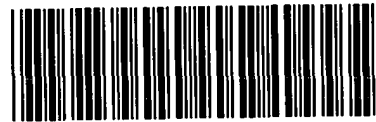

The principal activity of the company continued to be the provision of the sale of goods donated by the public.

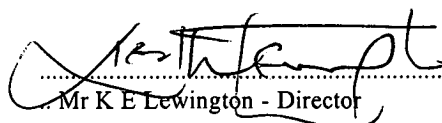

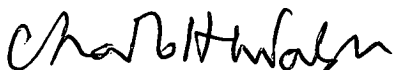

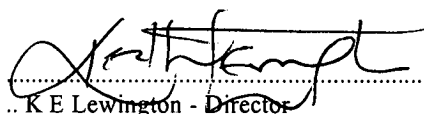

Turnover

During the year the company made a transfer of distributable reserves of £13,915 (2022 - £1,387) under an agreed covenant to Relate Milton Keynes. A management charge of £4,400 (2022 - £nil) was paid to Relate Milton Keynes to cover central overheads.
