Basis of Accounting

The Financial Statements are prepared under the historical cost basis of accounting and comply with applicable Accounting Standards.

The Company is exempt by virtue of section 400 of the Companies Act 2006 from the requirement to prepare group Financial Statements. These Financial Statements present information about the Company as an individual undertaking and not about its group.

Under FRS 1 the Company is exempt from the requirement to prepare a cash flow statement on the grounds that a parent undertaking includes the Company in its own published consolidated Financial Statements.

As the Company is a wholly owned subsidiary of CHS Inc., the Company has taken advantage of the exemption contained in FRS 8 and has, therefore, not disclosed transactions or balances with entities which form part of the group. The consolidated Financial Statements of CHS Inc., within which this Company is included, can be obtained from the US Securities and Exchange Commission.

These Financial Statements are presented in US dollars, which is the Company's functional currency. All financial information presented in dollars has been rounded to the nearest thousand.

Cash Flow

Under FRS 1 the Company is exempt from the requirement to prepare a cash flow statement on the grounds that a parent undertaking includes the Company in its own published consolidated Financial Statements.

Investments

Investments in subsidiaries are valued at cost less provision for impairment.

Foreign Currencies

Monetary assets and liabilities denominated in foreign currencies are translated into US dollars at rates of exchange ruling at the balance sheet date.

Transactions in foreign currencies are translated into dollars at the rate ruling on the date of the transaction.

Exchange gains are losses are recognised in the Profit and Loss Account.

Current and Deferred Taxation

Current tax, including UK corporation tax and foreign tax, is provided at amounts expected to be paid or recovered using tax rates and laws that have been enacted or substantively enacted at the Balance Sheet date.

Full provision is made for deferred tax assets and liabilities arising from all timing differences between the recognition of gains and losses in the Financial Statements and recognition in the tax computation.

13. Ultimate Parent Undertaking and Controlling Party

The Company's parent company is Sinav Limited. On 30 April 2014, Sinav Limited entered into an agreement to sell all of its outstanding shares to CHS Inc., a globally integrated Fortune 100 public company. The sale transaction completed on 4 June 2014. In the opinion of the Directors CHS Inc. is the ultimate controlling party.

The smallest and largest group for which consolidated accounts are prepared is CHS Inc. and consolidated financial statements are available from the US Securities and Exchange Commission.
