Particulars of the Agreement between Gencorp Services S.A ("Gencorp") to transfer the entire issued share capital of Conpor Inc. ("Conpor") to GTL Resources PLC (formerly BKG Resources PLC) ("BKG") (the "Acquisition")

In consideration of the transfer by Gencorp Services S.A. to BKG of the entire issued share capital of Conpor, BKG shall seek the approval of its shareholders for the issue, to Gencorp Services S.A (or as it may direct), of 118,803,882 Ordinary Shares of 1 penny each fully paid and free from all charges, liens, encumbrances, security interests and claims whatsoever (the "BKG Consideration Shares") and the BKG Consideration Shares shall be identical and rank pari passu in all respects with each other such Ordinary Share of BKG in issue at the date of issue of the BKG Consideration Shares and further BKG shall endeavour to procure that the BKG Consideration Shares shall be admitted to trade on the Alternative Investment Market of the London Stock Exchange.
