ORDER

UPON THE APPLICATION HEARING on 8 December 2014

AND UPON READING the evidence

AND UPON hearing Counsel for the Applicant

IT IS ORDERED THAT:

1 The Applicants do have permission to amend the Application Notice dated 2 December 2014 as follows

- a The word 'compulsory' shall be deleted from paragraph 5(3)(a)
- b Paragraph 5A be inserted as follows 'the Applicants be released from liability in relation to those matters other than liquidations and bankruptcies referred to in Schedules A-H on the date 28 days after the date of the relevant report as referred to in paragraph 5'
- c In paragraph 11 the word 'Respondents' shall be replaced by the words 'Replacement Office-Holders'

2 Reservice of the amended Application Notice is dispensed with

3 Paul John Clark be removed as

- Liquidator of the liquidations (compulsory, CVL and MVL)
- Trustee in Bankruptcy of the Bankruptcies
- Administrator of the Administrations

all listed on Schedules A-G shown at Exhibit PJC1 of the Witness Statement of Paul John Clark filed herewith pursuant to section 263(5) of the Insolvency Act 1986 (the Act) and that

- Paul David Williams of Duff & Phelps Ltd, The Shard, 32 London Bridge Street, London SE1 9SG be appointed in substitution of those matters shown in Schedule B,
- Geoffrey Bouchier of Duff & Phelps Ltd, The Shard, 32 London Bridge Street, London SE1 9SG be appointed in substitution of those matters shown in Schedule D,
- Benjamin Wiles of Duff & Phelps Ltd, The Shard, 32 London Bridge Street, London SE1 9SG be appointed in substitution of those matters shown in Schedule C,

4 David John Whitehouse be removed as

- Liquidator of the liquidations (compulsory, CVL and MVL)
- Trustee in Bankruptcy of the Bankruptcies
- Administrator of the Administrations

all listed on Schedules A-G shown at Exhibit PJC1 of the Witness Statement of Paul John Clark filed herewith pursuant to section 263(5) of the Act 1986 and that

- Philip F Duffy of Duff & Phelps Ltd, The Chancery, 58 Spring Gardens, Manchester M2 1EW be appointed in substitution of those matters shown in Schedule A,

- Steven Muncaster of Duff & Phelps Ltd, The Chancery, 58 Spring Gardens, Manchester M2 1EW be appointed in substitution of those matters shown in Schedule F,
 - Stephen Gerard Clancy of Duff & Phelps Ltd, The Chancery, 58 Spring Gardens, Manchester M2 1EW be appointed in substitution of those matters shown in Schedule E,
 - Sarah Helen Bell of Duff & Phelps Ltd, The Chancery, 58 Spring Gardens, Manchester M2 1EW be appointed in substitution of those matters shown in Schedule G,
- 5 Paul John Clark and David John Whitehouse be removed as administrator of the administrations and liquidator of the liquidations shown at Schedule H,
- 6 Where required, the proceedings herein to be transferred to the High Court for the purpose of making the order sought and thereafter back to the respective County Court,
- 7 Notice of this Order shall be given to creditors in the next report due to be circulated to creditors in the proceedings listed in the Schedules numbered A-H and by way of advertising in the London Gazette. Such notice shall state
- (1) that the respective Applicant has been removed from office and replaced by the relevant replacement office holder ('the Replacement Office Holder'),
 - (2) that the creditors have liberty to issue an application on notice within 28 days after the date of the report or advertising in the London Gazette, whichever is the earlier to vary or discharge the Order;
 - (3) that
 - (a) the respective Applicant will be entitled to apply to the Secretary of State for his release after the expiry of a period of 28 days commencing with the date of the report in relation to liquidations and bankruptcies,
 - (b) the respective Applicant be released from liability in relation to those other matters listed in Schedules A-H not covered by sub paragraph (a) above 28 days after the date of the report,
- 8 In the event that the next report due in each matter listed in the Schedules A-H is due within 28 days of the making of this Order, an extension of a further 56 days after the due date shall be permitted for the drafting and circulation to creditors of such report,
- 9 A creditor of any of the estates listed in the Schedules shall have liberty to issue an application on notice within 28 days of the date of the report containing the notice referred to above or advertising in the London Gazette, whichever is the earlier, to vary or discharge the Order
- 10 The Proposals (and resolutions contained therein) to creditors in each administration be read as if the relevant replacement office holder was originally stated in place of the relevant original office holder, with the effect that where the original office holder was proposed and then resolved to be appointed as liquidator on any subsequent liquidation, the relevant replacement office holder will be deemed to have been resolved to be appointed in his place
- 11 Where a replacement office holder is appointed, in substitution for an outgoing office holder, he or she shall act jointly and severally with their joint appointment holder, unless the outgoing office holder did not so act, in which case they shall act in the same capacity as the outgoing office holder previously did

- 12 In relation to the insolvency proceedings listed in the schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contains any requirement for advertisement, the requirement shall be dispensed with (subject to further order of the Court) Insofar as the Applicants are required by law to give any notice of the removal from office, the Replacement Office Holder is entitled to sign and send any such notice on their behalf
- 13 As soon as reasonably practicable after the making of the order of the Court, the Replacement Office-Holders shall lodge with each of the courts mentioned in the Schedules hereto one copy of the sealed order for each case under the jurisdiction of that court, for filing on the court file relating to that case
- 14 There be no order as to costs
