Directors' responsibilities

We read the other information contained in the Annual Report and consider the implications for our report if we become aware of any apparent misstatements or material inconsistencies with the financial statements.


Basis of audit opinion

Notes to the financial statements for the year ended 30 September 2000

Accounting policies

1 Accounting convention

The financial statements are prepared under the historical cost convention, and in accordance with applicable accounting standards.

- 2 The Company has an authorised share capital of 100 ordinary shares of £1 each. On incorporation 1 ordinary share of £1 was issued at par. No shares have been subsequently issued.

3 Turnover

Turnover comprises sales of printed matter supplied to the company's parent undertaking totalling £13,231 (1999: £Nil).

- 4 The directors received no emoluments in respect of their services to the Company (1999-£Nil). The Company had no employees (1999-Nil). Auditors emoluments were paid by the parent undertaking.

- 5 The Company's immediate and ultimate parent undertaking is the City and Guilds of London Institute, an organisation formed under Royal Charter which is a charity registered in England and which operates worldwide. The principal address of the City and Guilds of London Institute is 1 Giltspur Street, London, EC1A 9DD. Group accounts have been prepared as at 30 September 2000 and may be obtained from the Secretary at the above address.

6 Taxation

Taxation is provided on chargeable profits together with deferred taxation. Deferred taxation is accounted for at the rate of tax at which reversal is expected in respect of timing differences between profit as computed for taxation purposes and profit as stated in the accounts, other than those differences which are expected to continue for the foreseeable future.

7 Related party transactions

The Company is wholly owned by its parent undertaking. The Company has therefore elected to make use of the exemption provided in Financial Reporting Standard No. 8 ("Related Party Transactions") not to disclose related party transactions with other members of the City & Guilds Group.
