PRINCIPAL ACTIVITIES


The principal activity of the company is to raise funds by trading, for the benefit of its parent undertaking, The Childrens Family Trust. The company was dormant throughout the year.


For the year ended 31 December 2002 the company was entitled to exemption under section 249AA(1) of the Companies Act 1985.
