# EUROPEAN AVIATION AIR CHARTER LIMITED (COMPANY VOLUNTARY ARRANGEMENT) ("CVA")

Meeting of creditors held on 25 July 2005 at Hotel du Vin, Church Street, Birmingham at 11.00am for the purposes of considering a variation to the terms of the original CVA proposal agreed by the creditors.

Various creditors and their representatives in accordance with the attached copy attendance record.

The variation proposed was that the CVA be extended until 30 September 2005 in order that employee and other claims could be agreed and a final dividend paid. The original proposal agreed that all funds would be distributed by 31 July 2005. As this was not practically possible the Joint Supervisor had requested the extension of time.

The resolutions put to creditors were as follows:

#### **Resolution One**

That the Supervisor has the power to agree the contingent claims of employees who have submitted their claims by 31 March 2005.

## **Resolution Two**

That the period of the arrangement is to end on 31 September 2005 to enable the Supervisor to make a first and final distribution to unsecured creditors.

I attach a schedule which details the voting at the meeting.

The resolutions required a majority in excess of 75% of those present and voting to be passed.

Resolution one was passed by 99.7% of creditors voting at the meeting.

Resolution two was passed by 99.4% of creditors voting at the meeting.

Both resolutions were passed.
