Under the Articles of Association, only leaseholders of Blenheim Court may serve as Directors. The Director who served during the year was:

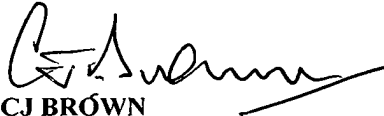
