Figure 1. Schematic representation of the experimental design. The study was divided into two phases: a pre-test phase and a main phase. The pre-test phase was used to determine the optimal number of trials for each condition. The main phase was divided into two blocks: a block for the control condition and a block for the experimental condition. The control condition consisted of a series of trials in which the participant was asked to identify the target stimulus. The experimental condition consisted of a series of trials in which the participant was asked to identify the target stimulus and to perform a secondary task. The results of the pre-test phase and the main phase are presented in the text.
