1 REPORTING ENTITY

These financial statements are prepared for Barclays Executive Schemes Trustees Limited (The Company'), the principal activity of which is being a pension fund trustee. The Company is a wholly owned subsidiary of Barclays Bank PLC and its ultimate parent company is Barclays PLC, both of which prepare consolidated financial statements in accordance with IFRS, and accordingly consolidated financial statements have not been prepared.
