

BETWEEN:-

- (1) MICHAEL FRANCIS BROWNE of Fiora, 3 North Hill, Dinnington, Ponteland, Newcastle
 Upon Tyne NE13 7LG (the "Seller"); and
- (2) A SHARE & SONS (HOLDINGS) LIMITED of 45-49 Villiers Street, Sunderland, SR1 1AH (the "Company").

WHEREAS:-

(A) The Company was incorporated in England under company number 2854197 under the Companies Act 1985 and has a share capital as follows:-

- (B) The Seller is the beneficial owner of 75,177 issued preference shares ("the Sale Shares").
- (C) The Company has power to purchase its own shares in pursuance of Part V of the Companies

- (D) The terms of this Agreement were authorised by a written resolution of the Members of the Company passed on the same date as this Agreement.
