### **DIRECTORS' REPORT**

The Directors present their report and the financial statements of ALIT (No. 3) Limited (the Company) for the year ended 31 December 2020.

#### **Legal status of the Company**

The Company is a private limited company, limited by shares, incorporated and registered in England and Wales.

#### **Principal activities**

The Company is a corporate member of the Society of Lloyd's. The Company is a corporate vehicle which was formed solely to underwrite on Lloyd's syndicates from the commencement of the 1994 underwriting year. Throughout the year the Company had no open syndicate participations. No business was transacted in 2020 or 2019.

#### **Results and dividends**

The result after taxation attributable to shareholders was £nil (2019: £nil). The Company have not proposed a final dividend for 2020 (2019: £nil). The Directors have not paid an interim dividend in 2020 (2019: £nil).

#### **Directors and their interests**

The Directors who held office throughout the year and up to the date of signing the financial statements are detailed on page 1.

No Directors had any interest in the voting share capital of the Company at any time during the year.

During the period from 1 January 2020 to (and including) the date of approval of this report, the Company provided its Directors and Officers with a qualifying third party indemnity and cover under an annual Directors and Officers insurance policy taken out by Chaucer.

#### **Going concern basis**

The financial statements are prepared under the going concern basis as a related group undertaking, Chaucer Holdings Limited, has indicated its willingness to support the Company for the foreseeable future.

#### **Statement of Directors' responsibilities**

The Directors are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulation.

Company law requires the Directors to prepare financial statements for each financial year. Under that law the Directors have prepared the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards, comprising FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", and applicable law). Under company law the Directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that financial year. In preparing the financial statements, the Directors are required to:

- select suitable accounting policies and then apply them consistently;
- state whether applicable United Kingdom Accounting Standards, comprising FRS 102, have been followed, subject to any material departures disclosed and explained in the financial statements;
- make judgements and accounting estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The Directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006.

The Directors are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020

#### 1. Basis of preparation

The financial statements have been prepared in compliance with United Kingdom Accounting Standards, including Financial Reporting Standard 102, "The Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland" ("FRS 102") and the Companies Act 2006.

The financial statements have been prepared on the going concern basis, under the historical cost convention and in accordance with applicable UK law and accounting standards (UK GAAP).

The Company is wholly-owned by a member of China Reinsurance (Group) Corporation, a company incorporated and registered in China (Note 5), and is included in the consolidated financial statements of China Reinsurance (Group) Corporation, which are publicly available. Consequently, the Company has taken advantage of the exemption from preparing a cash flow statement under the terms of FRS 102 and the exemption from the obligation to prepare and deliver group financial statements under section 401 of the Companies Act 2006.

The financial statements present information about the individual entity and not as a group. The Company is also exempt under the terms of FRS 102 from disclosing related-party transactions with the ultimate parent company or any of its wholly owned subsidiaries.

#### 2. Directors' emoluments and staff costs

No Directors received any emoluments for their qualifying services to the Company during the year ended 31 December 2020 (2019: £nil).

There were no staff costs incurred by the Company during the year ended 31 December 2020 (2019: £nil). The Company has no employees (2019: nil).

#### 4. Contingent liabilities

Where the Company reduces its participation on a syndicate it pays a reinsurance to close premium to other Lloyd's Names to assume its ongoing liabilities. The nature of this arrangement is that of reinsurance such that the Company retains liability in the event of failure of these Lloyd's Names and the Lloyd's chain of security. There is no mechanism for the Company to quantify its exposure in this regard and the Directors consider that the possibility of having to assume these liabilities is remote.

#### 5. Immediate and Ultimate parent company

The Company's immediate parent company is ALIT Underwriting Limited.

The largest and smallest group of undertakings for which group financial statements are prepared is China Reinsurance (Group) Corporation, a company incorporated and registered in China. The Company considers China Reinsurance (Group) Corporation to be its ultimate parent company.
