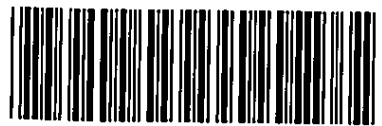

The Directors who held office during the year were as follows -

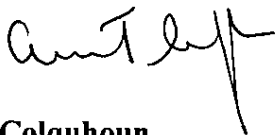
