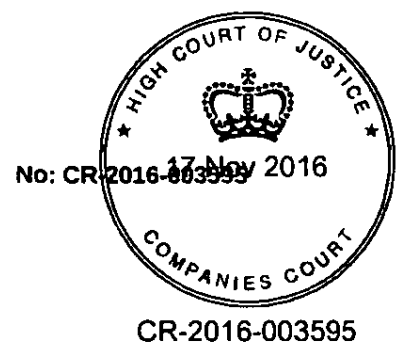

IT IS ORDERED

- 1 The County Court proceedings listed in Schedule F (*Bankruptcies*) to this Order be transferred to the High Court for the purpose only of this application and forthwith after the making of this Order be transferred back to the County Court

- 2 In respect of each Members' Voluntary Liquidation listed in Schedule A (*Members' Voluntary Liquidations*) to this Order, pursuant to section 108 of the Insolvency Act 1986
  - a Mr Neil John Mather be removed as joint liquidator
  - b Mr Irvin Cohen be appointed as joint liquidator on the same terms as Mr Mather previously acted
- 3 In respect of each Creditors' Voluntary Liquidation listed in Part I of Schedule B (*Creditors' Voluntary Liquidations*) to this Order, pursuant to section 108 of the Insolvency Act 1986
  - a Mr Neil John Mather be removed as joint liquidator
  - b Mr Irvin Cohen be appointed as joint liquidator on the same terms as Mr Mather previously acted
- 4 In respect of each Creditors' Voluntary Liquidation listed in Part II of Schedule B (*Creditors' Voluntary Liquidations*) to this Order, pursuant to section 108 of the Insolvency Act 1986

- 8 In respect of each Compulsory Liquidation listed in Part II of Schedule C (*Compulsory Liquidations*) to this Order, pursuant to section 172(2) of the Insolvency Act 1986, Mr Neil John Mather be removed as joint liquidator
- 9 In respect of each Provisional Liquidation listed in Part I of Schedule D (*Provisional Liquidations*) to this Order, pursuant to sections 135 and 172(2) of the Insolvency Act 1986 and Rules 4.31(1) and 4.31(2) of the Insolvency Rules 1986
  - a Mr Neil John Mather be removed as joint provisional liquidator
  - b Mr Irvin Cohen be appointed as joint provisional liquidator on the same terms as Mr Mather previously acted

- 10 In respect of each Provisional Liquidation listed in Part II of Schedule D (*Provisional Liquidations*) to this Order, pursuant to sections 135 and 172(2) of the Insolvency Act 1986 and Rules 4 31(1) and 4 31(2) of the Insolvency Rules 1986
  - a Mr Neil John Mather and Mr Andrew David Dick be each removed as joint provisional liquidator
  - b Mr Irvin Cohen and Mr Mark Robert Fry be each appointed as joint provisional liquidator on the same terms as Mr Mather and Mr Dick respectively previously acted
- 11 In respect of each Administration listed in Schedule E (*Administrations*) to this Order, pursuant to paragraphs 63 and 88 of Schedule B1 to the Insolvency Act 1986
  - a Mr Neil John Mather be removed as joint administrator
  - b Mr Irvin Cohen be appointed as joint administrator on the same terms as Mr Mather previously acted
- 12 In respect of each Bankruptcy listed in Schedule F to this Order (*Bankruptcies*), pursuant to section 298 of the Insolvency Act 1986
  - a Mr Neil John Mather be removed as joint trustee in bankruptcy
  - b Ms Julie Palmer be appointed as joint trustee in bankruptcy on the same terms as Mr Mather previously acted
- 13 The period to be covered by progress reports to creditors and the dates by which those reports need to be sent to creditors and filed with the registrar of companies (if applicable) shall not be altered by virtue of the making of this order or the replacement of the Applicants pursuant to this order, and this provision shall override any requirement in the Insolvency Rules 1986 that would otherwise require a report to be made to creditors or would otherwise alter the period to be covered by progress reports or the dates by which those reports need to be sent to creditors and companies house, on the termination, commencement of replacement of an office holders appointment, including those set out in rules 4 49B(5), 4 49C-CVL(3) and 6 78A(4) of the Insolvency Rules 1986
- 14 Pursuant to section 174(5) of the Insolvency Act 1986 and paragraph 98(2)(c) of schedule B1 thereto
  - a Mr Neil John Mather be released from liability in respect of acts and omission of his in
    - i the provisional liquidations listed in Schedule D (*Provisional Liquidations*) to this Order, and
    - ii the administration of Pnest & Co Ltd,
  - b Mr Andrew David Dick be released from liability in respect of acts and omission of his in the provisional liquidations in Part II of Schedule D (*Provisional Liquidations*) to this Order,

with effect from the date falling 28 days of the notice referred to in paragraph 16 below
- 15 Each creditor of any of the persons listed in the Schedules to this Order has permission to apply to vary or discharge this Order (insofar as it relates to a person of whom they are a creditor) within 28 days of the notice referred to in paragraph 16 below
- 16 The Applicant must give notice of this Order to the creditors of the persons listed in the Schedules to this Order within 28 days of this Order by means of an advertisement in the London Gazette

17 The costs of and incidental to this Application which may be recharged as costs of the procedures set out in each of the Schedules to this Order are fixed at £7,587 70 These costs shall

a subject to (b) below, be borne in equal shares between the each of the procedures set out in each of the Schedules to this Order, as expenses of the relevant officeholders in that procedure, and

b if the costs which fall to be borne by any estate of any natural or incorporated person subject to the procedures listed in the Schedules to this Order would exceed 10 per cent of the readily realisable assets of that estate

i such estate will bear an amount equal to that sum, and

ii the costs payable by the other estates shall be determined pursuant to the following formula

$$A + B / (C - D)$$

Where

A = the aggregate cost divided by the number of procedures set out in the Schedules to this order

B = the aggregated difference between A and 10 per cent of the readily realisable assets in the case of each estate

C = the number of estates where the costs do not exceed 10 per cent of the readily realisable assets

D = the number of estates where the costs exceed 10 per cent of the readily realisable assets
