

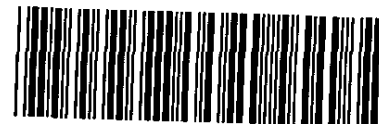

INTRODUCTION

The Company was placed into members' voluntary liquidation on 20 April 2017 when Emma Cray and Robert Nicholas Lewis were appointed joint liquidators (the liquidators).

We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 20 April 2017 to 8 June 2018 and also serves as a progress report from 20 April 2018 to 8 June 2018.

We are also required to give you certain information about the Company and the liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

REPORT ON THE LIQUIDATION

Realisation of assets:

The directors' Declaration of Solvency showed that the Company had no assets.

Realisations from the Company's assets during the liquidation totalled £1,326 and consisted of:

No additional assets have been identified. There are no assets still to be realised.

Settlement of liabilities:

This section covers all liabilities except any claims of HM Revenue & Customs (HMRC) which are dealt with separately below under HMRC.

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No claims were received.

HMRC:

The directors' Declaration of Solvency and the Company's records showed that the Company had no tax liabilities.

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities and confirmed their agreement to us closing the liquidation.

Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of:

- 18,165,980 £0.25 ordinary Type A shares
- 3,046,316 £0.25 ordinary Type B shares.

On 12 March 2018 we made a distribution in specie of £1328 (representing £0.25 per share) to the shareholders.

The distribution in specie consisted of an inter-group debtor balance together with any other assets held by the Company. The value attributed to the in specie distribution was based on the value at which the asset was held in the Company's books.

OUR FEES AND EXPENSES

Basis of remuneration:

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

Funding of the liquidation:

Although fees have been paid to us on the basis specified above, our fees and expenses have not been paid out of the liquidation estate. Instead, The Doctors Laboratory Limited has met our fees and expenses for the Company and 17 connected companies.

Remuneration charged:

Our fees for undertaking this assignment consist of time costs incurred for both (i) the period up to the day of our appointment and (ii) the period covering the formal liquidation. Our time costs for these periods were:

The above time costs for the liquidation period are calculated to 1 June 2018, being the latest practicable date. This represents 91 hours at an average hourly rate of £248.

£40,762 has been invoiced for this case. It is our normal practice to obtain the prior approval of The Doctors Laboratory Limited before fees are invoiced. Our final invoice to conclude this liquidation and the liquidation of a further 17 connected companies is £15,762, which is broken down as follows:
