REPORT OF THE DIRECTORS

The Directors present their report together with the audited financial statements of the Company for the year ended 31 December 2002.

PRINCIPAL ACTIVITY OF THE COMPANY

The Company is a general partner in The Granville Private Equity Limited Partnership ("the Partnership") which invests in unquoted companies in the United Kingdom and elsewhere within the European Union. The Company has sole responsibility for the conduct and management of the Partnership's business. Under the terms of the Partnership agreement the Company has exercised its right to appoint Granville Baird Capital Partners Limited to act as manager of the partnership with substantially the same powers and duties as it would otherwise have retained.

RESULTS AND DIVIDENDS

The Company made a profit after taxation of £Nil (2001: £ Nil). The Directors do not propose to pay a dividend in respect of 2002 (2001: £Nil)

DIRECTORS AND THEIR INTERESTS

The Directors who served during the year are those shown above. The Directors who held office on 31 December 2002 had no interests in the share capital of the Company.

AUDITORS

Grant Thornton were appointed on 13 January 2003 to fill a casual vacancy in accordance with section 388 (1) of the Companies Act 1985. Grant Thornton offer themselves for reappointment as auditors in accordance with Section 385 of the Companies Act 1985.

We have audited the financial statements of Granville Baird Private Equity (General Partner) Limited for the year ended 31 December 2002 which comprise the Profit and Loss Account, the Balance Sheet and the related Notes numbered 1 to 9. These financial statements have been prepared under the accounting policies set out therein.

NOTES TO THE FINANCIAL STATEMENTS

1 ACCOUNTING POLICIES

A summary of the principal accounting policies are set out below, These have been applied consistently throughout the year and the preceding year.

- a) **Basis of preparation** The financial statements have been prepared in accordance with UK applicable accounting standards and under the historical cost convention.
- b) Cash flow statement The Company has taken advantage of the exemption from the requirement of Financial Reporting Standard No 1 (revised) to prepare a cash flow statement as during the year it was a wholly owned subsidiary undertaking of Robert W. Baird Group Limited, whose consolidated financial statements include those of the Company and are publicly available.
- c) Turnover Turnover represents Priority Profit Share arising from the Company's role as a general partner of The Granville Private Equity Limited Partnership.
- d) **Taxation** UK Corporation tax is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantially enacted by the balance sheet date.

Deferred tax is recognised on all timing differences where the transactions or events that give the group an obligation to pay more tax in the future or a right to pay less tax in the future, have occurred by the balance sheet date. Deferred tax assets are recognised when it is more likely than not that they will be recovered. Deferred tax is measured using rates of tax that have been enacted or substantively enacted by the balance sheet date.

e) **Related party transactions** - The Company has taken advantage of the exemptions available under Financial Reporting Standard 8, "Related Party Disclosures", not to disclose transactions with its parent and fellow subsidiary undertakings,
