other liabilities in respect of any borrowings or acceptance credits and capital, premiums, dividends, costs and expenses on any stocks, shares or securities and in each and every case whether in pounds sterling or any other currency) by any person, firm or company including but not limited to any company which is for the time being or is to become the holding company (as defined in Section 736 of the Companies Act 1985) or a subsidiary undertaking (as defined by Section 258 of the Companies Act 1985) of the Company or of the Company's holding company as so defined. Each such acts of the Company are hereby constituted additional main objects of the Company and all other provisions of the Memorandum and Articles of Association of the Company shall be construed and deemed amended to give full effect to the provisions of this paragraph of the Memorandum of Association of the Company

b) the consequential re-lettering of the existing paragraphs 3(M) to 3(bb) as paragraphs 3(N) to 3(cc)
