"FRI"	means a freehold reversionary interest or a leasehold reversionary interest (as the case may be);
"Group"	has the meaning defined in the Facilities Agreement and "Group Company" means any of them;
"Security Trustee"	means the Governor and Company of the Bank of Scotland and shall be construed to include its successors, assignees and transferees in respect of the Facilities Agreement;

Part 3

Amount secured by Mortgage or Charge

1. The Chargor covenants and guarantees that:
 - (a) it will on demand in writing made to it by the Agent pay to the Agent for the account of the Governor and the Company of the Bank of Scotland all moneys and discharge all obligations and liabilities which shall for the time being (whether on or at any time after such demand) be due, owing or incurred to the Governor and the Company of the Bank of Scotland by it or any other Group Company (including any other Company) in whatever manner when the same shall become due and payable; and
 - (b) it will on demand in writing made to it by the Agent at any time after the Agent is entitled under the terms of the Facilities Agreement to make such demand, pay to the Security Trustee for the account of the Lenders (as defined in the Facilities Agreement) and the Swap Counterparties all money and discharge all obligations and liabilities which shall for the time being (and whether on or at any time after such demand) be due, owing or incurred by it or by any other Group Company (including any other Company) to each of the Lenders and the Swap Counterparties under the Facilities Agreement and/or the Swap Agreement
2. The covenants and guarantees contained in clause 1 of this Part shall apply in each case:
 - (a) whether actually or contingently and whether solely or jointly with any other person and whether as principal or surety (under any document whether executed before, at the same time as, or at any time after execution of the Debenture); and
 - (b) whether or not such indebtedness, obligations or liabilities shall have been incurred directly to the Beneficiaries concerned or such Beneficiary is entitled to lodge a claim in respect thereof only by reason of the sale or assignment of such indebtedness or liability to it by the party originally entitled;

on the basis that interest (in the absence of express agreement to the contrary) shall be computed and compounded according to the provisions of the Facilities Agreement (or, in the case of the Working Capital Facilities, any Working Capital Facility Letter (with both terms as defined in the Facilities Agreement) as well after as before any demand made or judgment obtained hereunder.

Part 4

Particulars of Property Mortgaged or Charged

1. By clause 4.1 of the Debenture the Chargor with full title guarantee charged to the Security Trustee with the payment and discharge of all moneys and liabilities covenanted to be paid or discharged by it under the terms of the Debenture:-
 - (a) by way of first legal mortgage, all its freehold and leasehold property the title to which is registered at HM Land Registry (including but not limited to the interests of

the Chargor in the properties described in Part 6 of this Schedule) together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery at any time thereon;

- (b) by way of first legal mortgage, all other freehold and leasehold property now vested in it and not registered at HM Land Registry (including but not limited to the interest of the Chargor in the properties described in Part 7 of this Schedule) together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery at any time thereon;
- (c) by way of first fixed charge, all future freehold and leasehold property of the Chargor together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery at any time thereon;
- (d) by way of first fixed charge, all estates and interests, not effectively charged by clause 4.1(a) to (c) inclusive of the Debenture, at the Debenture Date or in the future belonging to the Chargor in or over land wheresoever situate or the proceeds of sale of land and all licences now or hereafter held by the Chargor to enter upon or use land and the benefit of all other agreements relating to land to which the Chargor is or may become a party or otherwise entitled and all trade and tenants' fixtures, plant and machinery owned by the Chargor at the Debenture Date or in the future annexed to all freehold and leasehold property its estate or interest in which stands charged under the terms of the Debenture;
- (e) by way of first fixed charge, all book debts both present and future due or owing to the Chargor and the benefit of all rights relating thereto including negotiable instruments, legal and equitable charges, reservation of proprietary rights; bank accounts (including without limitation, each and every account with any bank which is designated as a collection account for book and other debts, but excluding sums held on trust for third parties), rights of tracing and unpaid vendors' liens and similar and associated rights;
- (f) by way of first fixed charge, all other monetary debts and claims both present and future (including to the extent (if any) such Chargor has an interest in NHBC guarantees, NHBC guarantees) and including things in action which give rise or may give rise to a debt or debts, at the Debenture Date or in the future due or owing to the Chargor and the benefit of all rights relating thereto including such rights as are described in clause 4.1(e) of the Debenture and claims arising pursuant to the Swap Agreement;
- (g) by way of first fixed charge:-
 - (i) all stocks and shares and other interests both present and future including loan capital, indebtedness or liabilities on any account or in any manner owing to the Chargor in (and from) any company including, without limitation, in (and from) any company which is a Subsidiary of any of the Companies;
 - (ii) the full benefit of all stocks, shares and securities which, or the certificates of which, are now or may in the future be lodged with or held by or transferred to or registered in the name of the Security Trustee or its nominees;

- (iii) all rights in respect of or incidental to the premises described at (i) and (ii) above (the property described in (i) to (iii) inclusive charged pursuant to the terms of the Debenture being hereinafter called "the Securities"); and
- (iv) all stocks, shares, rights, moneys or property accruing or offered at any time by way of conversion, redemption, bonus, preference, option, or otherwise to or in respect of any of the Securities, including all dividends, interest and other income payable in connection therewith (all of which property described in (i) to (iv) inclusive, charged pursuant to the terms of the Debenture being hereinafter called "Interests in Securities"),

but so that the Security Trustee shall not in any circumstances incur any liability whatsoever in respect of any calls, instalments or otherwise in connection with Interests in Securities;

- (h) by way of first fixed equitable charge, the goodwill, trade marks and trade applications, service marks, copyrights, trade names, rights in the nature of copyright, design rights, all trade secrets and know-how and all applications for any of the foregoing and all other intellectual property rights worldwide at the Debenture Date or in the future obtained by the Chargor (and all goodwill associated therewith) or (to the extent that the same may be capable of becoming the subject of a valid charge) in which the Chargor may have an interest and the benefits of all present and future agreements entered into or the benefit of which is enjoyed by the Chargor relating to the use or exploitation of rights of such nature whether owned by the Chargor or others and the uncalled capital of the Chargor at the Debenture Date or in the future;
2. by way of floating charge, all the undertaking and all property and assets of the Chargor whatsoever and wheresoever both present and future including (without prejudice to the generality of the foregoing) heritable property and all other property and assets in Scotland, Northern Ireland and the Republic of Ireland and the property described in paragraphs (a) to (h) inclusive of clause 1 of Part 4 of this Schedule if and so far as the charges thereon (or assignments thereof) or on any part thereof herein contained shall for any reason be ineffective as fixed charges.

Part 5

Covenants and Restrictions

1. By clause 7 of the Debenture the Chargor agreed that it will, during the continuance of the security created pursuant to the terms of the Debenture:-
- (a) keep (or, where such obligation is reserved to a landlord under the terms of a lease, use all reasonable endeavours to procure that such landlord shall keep) all buildings and all plant, machinery, fixtures, fittings and other effects in a good state of repair to the extent necessary for the carrying on of such business, provided that where the Chargor is itself a landlord in respect of a property, the Chargor shall not be obliged to do more than it is under an obligation to or as freeholder under the relevant lease to which its FRI is subject;

- (b) subject to the leases relating to the FRIs, pay all rates, rents, taxes and other outgoings in respect of any leasehold, freehold and heritable property;
- (c) not make any structural alterations, material improvements or additions to any leasehold or freehold property without the prior written consent of the Security Trustee (such consent not to be unreasonably withheld or delayed) but the consent of the Security Trustee shall not be required where any such works are to a property in respect of which the Chargor is a reversioner under an FRI and such works are to be carried out pursuant to the terms of the leases or otherwise in accordance with good estate management;
- (d)
 - (i) subject to the provisions of the leases relating to the FRIs, comply with the terms of all statutes relating to the Charged Property;
 - (ii) not without the prior written consent of the Security Trustee (such consent not to be unreasonably withheld or delayed) carry out any development of the leasehold, freehold or heritable property within the meaning of the Town & Country Planning Act 1990 and the Town & Country Planning (Scotland) Act 1972 but the consent of the Security Trustee shall not be required where any such works are to a property in respect of which the Chargor is a reversioner under an FRI and such works are to be carried out pursuant to the terms of the leases or otherwise in accordance with good estate management;
- (e) use all reasonable endeavours to get in and realise all book debts and other debts and claims charged and pay all moneys which it may receive in respect thereof into its account with the Security Trustee and/or such other bank or banks as the Security Trustee may from time to time nominate forthwith on receipt and, pending such payment, hold all moneys so received upon trust for the Security Trustee and the Beneficiaries and shall not without the prior consent of the Security Trustee in writing purport to sell, charge, factor, discount or encumber or assign or otherwise sell or dispose of the same (or any interest therein) in favour of any other person, and shall if called upon to do so by the Security Trustee at any time after the occurrence of an Event of Default:-
 - (i) execute a legal assignment of such book debts and other debts and claims to the Security Trustee and give notice thereof to the relevant debtor; and/or
 - (ii) deliver such particulars as to the amount and nature of such book and other debts and claims as the Security Trustee may from time to time reasonably require;
- (f) provide the Security Trustee with copies of all notices which could reasonably be expected to have a material adverse effect on the value of the security hereby or otherwise created in favour of the Security Trustee;
- (g) subject to the rights of residents under the leases relating to the FRIs, permit the Security Trustee to inspect any property charged by the Debenture or pursuant to the Debenture;
- (h) comply in all material respects with the terms of all leases relating to the properties mentioned in Part 6 of this schedule and of all other leases and licences by virtue of which the Chargor holds any property and to enforce the covenants on the part of the

landlord or the licensor thereunder and also comply in all material respects within any obligation as landlord or licensor on the part of the Chargor in relation to any lease or licence granted by the Chargor in respect of any such property;

- (i) if the Security Trustee shall so require and at the Chargor's expense, cause to be executed and delivered to the Security Trustee all necessary deeds, documents and certificates to protect and perfect the security created or purported to be credited by security documents and to effect all necessary registration and service of notices and to perfect and protect such security;
- (j) ensure that the amounts guaranteed to be paid by the Chargor will at all times constitute the direct, unconditional and general obligations of the Chargor and, unless the Security Trustee otherwise agrees or as permitted by the Facilities Agreement, will rank (save in respect of statutory preferential debts) at least *pari passu* with all present and future outstanding indebtedness issued, created, assumed or guaranteed by the Chargor;
- (k) not, and shall procure that each other Group Company shall not, (save for any Encumbrance or security created in favour of the Security Trustee or otherwise expressly permitted by the Facilities Agreement) without the consent in writing of the Security Trustee, create, incur or permit to subsist any Encumbrance on any of its present or future property, assets or revenues to secure any liability, actual or contingent;
- (l) not voluntarily surrender or terminate any lease or licence by virtue of which the Chargor holds any Charged Property or voluntarily vary or waive or estop itself from enforcing the obligations on the part of the landlord or licensor contained therein except in compliance with the Borrowers' (as defined in the Facilities Agreement) covenant in the Facilities Agreement or with the prior consent of the Security Trustee.

2. By clause 4.5 of the Debenture the Chargor agreed (at its own cost), without prejudice to the generality of any of the other provisions contained in the Debenture, that it will at all times:-

- (a) as soon as reasonably practicable upon acquisition of any Interests in Securities deposit with the Security Trustee and permit the Security Trustee during the continuance of this security to hold and retain (i) all stock and share certificates and documents of title relating to Interests in Securities (ii) transfers of the Securities duly completed in favour of the Security Trustee or its nominee and (iii) such other documents as the Security Trustee may from time to time reasonably require for perfecting its title to Interests in Securities (duly executed by or signed on behalf of the registered holder) or for vesting or enabling it to vest the same in itself or its nominees or in any purchaser as it may from time to time nominate;
- (b) duly and promptly pay all calls, instalments or other payments which from time to time become due in respect of any Interests in Securities;
- (c) not without the prior written consent of the Security Trustee:-
 - (i) permit any person other than the Chargor, the Security Trustee or its nominee to be registered as holder of interests in Securities or any part thereof; or

- (ii) create or agree to create or permit to arise or subsist any Encumbrance on its Interests in Securities or any part thereof except Permitted Encumbrances (as defined in the Facilities Agreement); or
 - (iii) sell, transfer or otherwise dispose of Interests in Securities or any part thereof or in contravention of the covenants of the Borrowers contained in the Facilities Agreement.
 - (d) not do or cause or permit to be done anything which may in any way alienate or encumber the Chargor's title to any Interests in Securities such that the interests of the Security Trustee or the Beneficiaries would be prejudiced.
3. By clause 4.8 of the Debenture, the Chargor agreed that the Security Trustee may at any time and from time to time after the occurrence of an Event of Default which has not been remedied to the satisfaction of the Agent (as defined in the Facilities Agreement) or expressly waived by notice in writing to the Chargor convert the floating charge referred to in clause 2 of Part 4 of this Schedule into a specific charge as regards any Charged Property specified in such notice.
4. By clause 4.9 of the Debenture, the Chargor agreed that any fixed charge or fixed security created by the Chargor in favour of the Security Trustee (other than a fixed charge or fixed security arising by virtue of a floating charge attaching to the property subject thereto) shall rank prior to the floating charge created by the Chargor.
