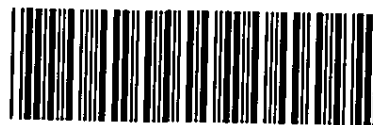

Appendix to Form AR01 – discrepancy between CD Rom and Part 3 of the Annual Return

The CD Rom shows an issued share capital of 64,832,663 shares. Part 3 of the Annual Return shows an issued share capital of 62,582,663 shares. This results in a difference of 2,250,000 shares.

As at the made up date of the Annual Return, 31 January 2011, 3,025,000 shares were held in treasury in account number 684769 by HSBC Global Custody Nominee (UK) Limited. A further 2,250,000 shares (equal to the difference above) also show in this account according to the Registrar. However, these had been cancelled from treasury and the relevant Forms SH05 filed with Companies House, but had not yet been removed from the Register as the registered holder, HSBC Global Custody Nominee (UK) Limited had not submitted the Forms of Discharge to the Registrar to effect their cancellation on the Register.

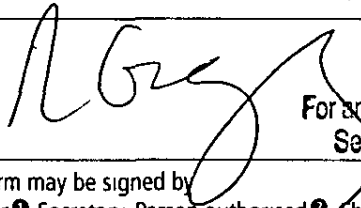
