I now supply my final report in respect of this Administration.

I enclose, for your information, a summary of my receipts and payments to date showing a balance in hand of £133,457.73, together with a copy of my abstract receipts and payments account covering the final period, and report as follows:

1 Receipts

The receipts shown are largely self-explanatory and remain unchanged since my last report save for interest received.

2 Realisation of Assets

The realisation of assets has for the large part been finalised with the exception of resolving one or two book debts and a potential refund due from HM Revenue & Customs for VAT bad debt relief.

3 Future of the Company

It was resolved at the initial meeting of creditors held on 17 May 2005 that the Company should exit the Administration by way of Creditors' Voluntary Liquidation and I am now in the process of filing the necessary documents at Companies House.

4 Prospects for Creditors

Under Section 176A of the Insolvency Act 1986 where after 15 September 2003 a company has granted to a creditor a floating charge a proportion of the net property of the company must be made available purely for the unsecured creditors. Based

on present information the Joint Administrators estimate that after allowing for costs the value of the company's net property, after payment of preferential claims will be approximately £117,000 and this means that the prescribed part should be £26,400.

5 Administrators' Remuneration

The creditors have already approved the Administrators' remuneration on a time costs basis and to date I have drawn £63,412.55 in respect of remuneration as shown on the attached receipts and payments account. I attach a schedule which summarises the time costs accrued to date and indicates the work undertaken in that respect.

6 Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. I therefore report that since my last report no funds have been drawn in respect of category 1 disbursements.

Category 2 disbursements require approval of creditors before they can be drawn. BDO Stoy Hayward LLP does not charge any category 2 disbursements.
