The Directors present their strategic report on AMMO (Advance Media & Marketing Opportunities) Limited ("the Company") for the year ended 31 December 2017.

REVIEW OF THE BUSINESS

The Company did not trade during the current or prior financial year.

The Company is a wholly owned subsidiary of Freshcorp Limited, a company incorporated in England and Wales, which itself is ultimately owned by Ebiquity plc, a company incorporated in England and Wales.

The Company has not traded during the current or preceding financial year and accordingly no profit and loss account has been prepared.

The Statement of Financial Position remained at total net assets of £1,325,000 (31 December 2016: £1,325,000) since the Company has not traded in the financial year.
