**UPON** the Application dated 1 December 2022 under Rule 12.37 of the Insolvency (England and Wales) Rules 2016 (“**Rules**”) and:

- (a) Section 7(5) of the Insolvency Act 1986 (“**Act**”);
- (b) Paragraph 88 of Schedule B1 of the Act and rule 12.36(2) of the Rules;

- (c) Section 108 of the Act;
- (d) Section 172(2) of the Act and rule 12.36(2) of the Rules;
- (e) Section 263(5) of the Act;
- (f) Section 298 of the Act and rule 12.36(2) of the Rules.

**AND UPON** reading the witness statement of the Third Applicant dated 1 December 2022 in support Application

**AND UPON** reading the letter of the Second Respondent dated 29 November 2022

**ON PAPER**

**IT IS ORDERED THAT**

Temporary Transfer of cases in Schedules to Leeds District Registry

1. Each of the Insolvency appointments set out in the attached Schedules in respect of which the County Court currently has jurisdiction be transferred to the High Court of Justice, Business and Property Courts in Leeds the purpose of this application only pursuant to Rule 12.37(1)(a) of the Insolvency (England and Wales) Rules 2016 ("**Rules**").
2. Immediately upon this order taking effect, the Insolvency appointments set out in the Schedule be transferred back to the County Court from which they were transferred (if any).

Removal of Alan Brian Coleman

3. Alan Brian Coleman ("**First Respondent**") shall be removed as joint officeholder on the cases listed in Schedule 1 of this Order with effect from the date of the order pursuant to Rule 12.37(1)(c) of the Rules.
4. Jason Mark Elliott ("**First Applicant**") or Craig Johns ("**Third Applicant**"), whoever is listed in the column headed "Officeholder to be Appointed" in respect of each case in Schedule 1 hereto, shall be appointed as replacement officeholders in respect of each of the cases listed in Schedule 1 of this Order pursuant to Rule 12.37(1)(d) of the Rules.

Appointment of Marco Piacquadio

5. Marco Piacquadio ("**Second Respondent**") shall be appointed as additional officeholder in respect of each of the cases listed in Schedule 2 of this Order pursuant to Rule 12.37(1)(d) of the Rules.

Removal of Jason Mark Elliott, James Fish, and Craig Johns and Appointment of Marco Piacquadio

6. Jason Mark Elliott ("**First Applicant**"), James Fish ("**Second Applicant**") and Craig Johns ("**Third Applicant**") shall be removed as joint officeholder on the cases listed in Schedule 3 of this Order with effect from the date of the order pursuant to Rule 12.37(1)(c) of the Rules.
7. The Second Respondent shall be appointed as replacement officeholders in respect of each of the cases listed in Schedule 3 of this Order pursuant to Rule 12.37(1)(d) of the Rules.

#### Service of this Order

8. The Applicants shall, as soon as reasonably practicable after they receive a copy of this order sealed by the Court ("**Order**") and in any event no more than 30 days after receipt of the Order:
  - 8.1. serve a sealed copy of the Order on the Respondents,
  - 8.2. serve a sealed copy of the Order on the Secretary of State,
  - 8.3. give notice of this Order by advertisement in the London Gazette, and
  - 8.4. lodge a sealed copy of the Order at any District Registry or County Court where a case listed in Schedule 1 is pending (if any).
9. The Respondents shall as soon as reasonably practicable after they receive a copy of this Order, and in any event no more than 30 days after receipt of the Order, lodge a sealed copy of the Order at any District Registry or County Court where a case listed in either Schedule 2 or 3 is pending (if any).
10. In respect of the cases listed in Schedule 1, the relevant Applicants shall, at the time of the next annual or other report to creditors, whichever is appropriate, give notice of the making of the order and its terms and shall contain reference to and explanation of the effect of this Order and the liberty to apply provision in paragraph 17 below.
11. In respect of the cases listed in Schedules 2 and 3, the Respondents shall, at the time of the next annual or other report to creditors, whichever is appropriate, give notice of the making of the order and its terms and shall contain reference to and explanation of the effect of this Order and the liberty to apply provision in paragraph 17 below.

#### Ancillary Provisions of this Order

##### 12. Any:

- (i) creditor in respect of any of the persons listed in the Schedule; or
- (ii) in respect of the members' voluntary liquidations any member

who has an objection to this Order shall have 21 days from the date of the advertisement placed in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the Court.

13. The remuneration and the costs and expenses incurred by the Applicants and/or the Respondents in connection with this Application and the implementation of this Order which are referable to this Application generally shall be divided equally between all matters listed in Schedule 1, Schedule 2 and Schedule 3 ("**Block Transfer Cases**") and that the same be paid in the ordinary way as remuneration or as a cost and expense of the officeholder of each matter. The costs and expenses chargeable to each matter are not to exceed the sum of £80 plus VAT thereon.

14. The parties removed from office under paragraphs 3 and 6 of the Order ("**Removed Officeholder**") shall be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to their conduct as officeholder of the relevant estates. Such release shall take effect (as appropriate)

- (i) 28 days after giving of notice to creditors in accordance with paragraph 8.3 of the Order; or
- (ii) 28 days after filing notice of removal with the Registrar of Companies

save in respect of any claim notified to the Removed Officeholder pursuant to the Act and/or pursuant to such other provision as may apply on or prior to the notice date save that the release may be subject to a further order in the event of an application by any creditor or member under paragraph 8.4 or 9 of this Order for the specific case subject to that application.

15. Nothing in this Order shall release the Removed Officeholder from any obligation to give and file notices at Companies House in respect of their removal under this Order in respect of the Block Transfer Cases.

16. The joint officeholders appointed pursuant to paragraphs 4, 5 or 7 of the Order ("**Appointed Officeholder**") shall act jointly and severally in relation to all matters relating to the administration of the Block Transfer Cases.

17. Any party shall have liberty to apply to the Court to amend this Order to include any appointments held by the First Respondent which have been inadvertently omitted from the Application.

18. The terms of this Order shall not apply to any case which is listed in the Block Transfer Cases but which, prior to the Order being sealed by the Court, is concluded and the case closed (in which case for the avoidance of doubt the appointment of the relevant Appointed Officeholder will not take effect in respect to that case)

19. Such further order as the Court thinks fit.

20. The costs of the Application (including VAT thereon) shall be met 50% by the Applicants and 50% by the Respondents
