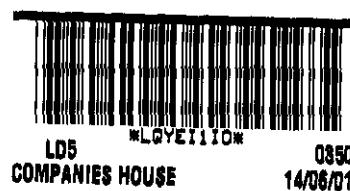

## STATEMENT OF DIRECTORS' RESPONSIBILITIES
