### **Director's Report**

#### **Principal Activities**

The company continued its catering franchise at The Grand, Folkestone, during the year.

#### **Director's Responsibilities**

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for prevention and detection of fraud and other irregularities.

#### **Results**

There was a loss of £946 for the period. The director considers the company's current financial position as shown in these accounts to be satisfactory.
