#### 6 Related party transactions

The company has taken advantage of the exemptions under Financial Reporting Standard No 8 as a wholly owned subsidiary and has not disclosed transactions with companies that are part of the Sterling Capitol plc group.

#### 7 Ultimate parent undertaking

The company's immediate parent undertaking is Zonearchive plc, a company registered in England and Wales.

The ultimate parent undertaking and controlling party is Sterling Capitol plc, which is the parent undertaking of the largest group to consolidate these financial statements. Group accounts will be prepared by this company and will be available from Companies House.
