ORDER

Before District Judge Rich sitting at Birmingham Civil Justice Centre, 33 Bull Street,
Birmingham B4 6DS

UPON THE APPLICATION of the Applicants dated 26 February 2020

AND UPON READING the evidence

IT IS ORDERED:

1. That the Applicants have leave to make a composite application in respect of the insolvency proceedings identified in the Schedules A to E attached to this application ("the Schedules").
2. That the proceedings listed in the Schedules, in so far as there are currently proceedings in any County Court or any District Registry in England and Wales other than the Birmingham District Registry, be transferred to the Birmingham District Registry solely for the purpose of considering and, if thought fit, making the orders listed below.
3. That the Applicants do ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the Court having jurisdiction over each case affected by such order for filing on the Court file relating to that case.
4. That the time for service of this application be abridged to permit the application to be heard at such time as this Court shall think fit.
5. Pursuant to Section 108(2) of the Act, Emily Ball ("the First Applicant") be removed from her office as joint liquidator of the companies listed in Schedule A, hereto as being in Creditors' Voluntary Liquidation.
6. Pursuant to Section 108(2) of the Act, Yasmin Bhikha ("the Second Applicant"), be appointed as joint liquidator of the companies listed in Schedule A hereto as being in Creditors' Voluntary Liquidation.
7. Pursuant to Section 108(2) of the Act, the First Applicant be removed from her office as joint liquidator of the companies listed in Schedule B hereto being in Members' Voluntary Liquidation;
8. Pursuant to Section 108(2) of the Act, the Second Applicant be appointed as joint liquidator of the companies listed in Schedule B hereto as being in Members' Voluntary Liquidation;
9. Pursuant to Section 19, Paragraph 88 of Schedule B1 to the Act and Rule 12.36(2) of the Rules, the First Applicant be removed from her office as joint administrator of the companies identified in Schedule D hereto as being in administration.
10. Pursuant to Section 13, Paragraphs 63, 91 and 95 of Schedule B1 to the Act and Rule 12.36(2) of the Rules, the Second Applicant be appointed as joint administrator of the companies identified in Schedule D hereto as being in administration;
11. The Proposals (and resolutions contained therein) to creditors in each administration be read as if the relevant replacement office holder was originally stated in place of the First Applicant with the effect where the First Applicant was proposed and then resolved to be appointed as liquidator on any subsequent liquidation, the relevant replacement office holder will be deemed to have been resolved to be appointed in her place.
12. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Rules, the First Applicant be removed from her office as joint liquidator of the company identified in Schedule C hereto as being subject to a Compulsory Winding Up Order;

13. Pursuant to Section 168(3) and (5) of the Act and Rule 12.36(2) of the Rules, the Second Applicant be appointed as joint liquidator of the company identified in Schedule C hereto as being subject to a Compulsory Winding Up Order.
14. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules the First Applicant be removed from her office as sole trustee in bankruptcy of the individuals listed in Schedule E, part 1 hereto;
15. Pursuant to Sections 298 and 303(2) of the Act and Rule 12.36(2) of the Rules, the Second Applicant be appointed as trustee in bankruptcy of the individuals listed in Schedule E, part 1 hereto;
16. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules the First Applicant be removed from her office as joint trustee in bankruptcy of the individual identified in Schedule E, part 2 hereto;
17. Pursuant to Sections 298 and 303(2) of the Act and Rule 12.36(2) of the Rules, the First Applicant be appointed as joint trustee in bankruptcy of the individual identified in Schedule E, part 2 hereto;
18. The creditors of the companies and LLPs listed in the Schedules be notified of the Order by advertisement in the London Gazette within 14 days of the date of the Order and at the time of the next statutory reporting requirement for each case;
19. The Applicants shall notify the Secretary of State of the Order as soon as reasonably practicable after it is made;
20. All creditors of the companies, LLPs, and individuals listed in the Schedules do have permission to apply to the Court, on notice to the Applicants, within 28 days of being given notice of the terms of any Order made for the purposes of applying to vary or discharge the Order in so far as it affects the company or companies or bankruptcy estates of which they are a creditor;
21. There be no order as to costs;
22. Any cases listed in the Schedules which, pursuant to paragraph 2 above are transferred to the Birmingham District Registry be transferred back to the County Court or District Registry from which they originated.
23. This order has been made by the court under CPR 23.9, as the court has disposed of the application without a hearing and without service. Any party may apply to have this order set aside or varied within 7 days of the date of service of this order on that party
