UPON HEARING Counsel for the Applicant and Solicitors for the First, Second and Third Respondent.

It is ordered that

1. The Appointments of the First Respondent Robert Preston James Allen made by the Order dated 3 September 2002 (as amended on 21 September 2002) and by the Order dated 18 October 2002 in respect of the Companies set out in Paragraph 1 of the Schedule hereto are hereby revoked.
2. The appointments of the Second Respondent Colin Anthony Sefton made by the Order dated 3 September 2002 (as amended on 21 September 2002) and by the Order dated 18 October 2002 in respect of the Companies set out in paragraph 2 of the Schedule hereto are hereby revoked provided that the revocation of the appointment of the Second Respondent as Administrator of UK Scaffolding (Manchester) Limited shall be suspended pending the determination of the Application to discharge the Administration Order and upon such discharge the said revocation shall have no effect.
3.
