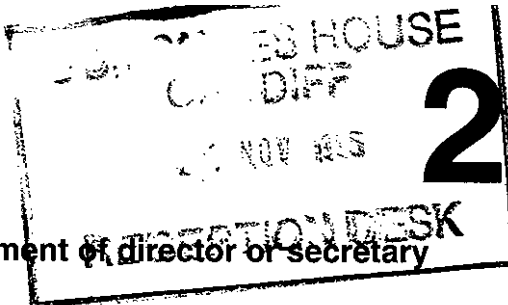

NOTES
