

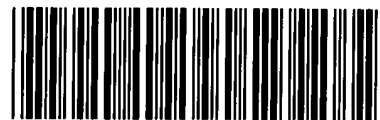

Business Review


