As at 31 July 2012, Dewmead Limited had a loan balance outstanding to Goodwin Associates Limited of £25,000 (2011 £25,000), a company in which S R Adkins has a controlling interest

At as 31 July 2012 the company was owed a loan balance of £2,204 (2011 - £2,204) from London Interspace Co Limited, a company in which S R Adkins has a material interest

S R Adkins and A T Scott have both guaranteed a sum of £65,000 against the bank loan held by Dewmead Limited
