

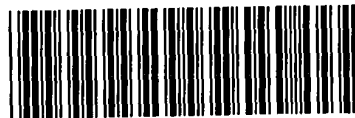


Principal activities and review of the business



1. Accounting policies

Basis of preparation

Defiance Tools Limited is a company incorporated in the United Kingdom under the Companies Act. The address of the registered office is Unit 1A, Badminton Road Trading Estate, Yate, Bristol, BS37 5JS. The nature of the company's operations and its principal activities are set out in the strategic report on page 2.

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland and the Companies Act 2006.

The company's financial statements are presented in sterling and all values rounded to the nearest thousand pounds (£'000) except when otherwise indicated

Exemptions for qualifying entities under FRS 102:

FRS 102 allows a qualifying entity certain disclosure exemptions. A qualifying entity is defined as a member of a group that prepares publicly available financial statements, which give a true and fair view, in which that member is consolidated. Defiance Tools Limited is a qualifying entity as its results are consolidated into the financial statements of Kroymans Holding B.V. a company incorporated in The Netherlands, , the registered office is Soestdijkerstraatweg 66A, 1213 XE, Hilversum, The Netherlands.

As a qualifying entity, the Company has taken advantage of the following exemptions:

- i) from preparing a statement of cash flows, on the basis that it is a qualifying entity and the consolidated statement of cash flows, included in these financial statements, includes the Company's cash flows (FRS 102 paragraph 1.12(b))
- ii) not to disclose related party transactions with other group companies which meet the criteria that all subsidiary undertakings which are party to the transactions are wholly owned by the ultimate controlling party (FRS 102 paragraph 33.1(a))

The company has taken advantage of the exemption within FRS102 not to restate the opening balance sheet as at the date of transition (nor any subsequent balance sheets) until there is a change in its existing balances or the company undertakes any new transactions.

The company has taken advantage of the exemption under s400 of the Companies Act 2006 not to prepare group accounts as it is a wholly owned subsidiary of Kroymans Holdings B.V. a company incorporated in The Netherlands, whose consolidated accounts are publicly available. These financial statements therefore provide information about the company, not the group.

Profit and loss account

The company has been dormant throughout the year and has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

Going concern

In assessing the appropriateness of the application of the going concern basis, the directors have considered the trading performance of the company, the available cash and the support of the parent undertaking. The directors are of the view that it is appropriate to apply the going concern basis.

Investments

Investments in subsidiary undertakings are stated at cost less provisions, where in the opinion of the directors there has been a permanent diminution in value.

2. Trading activity

During the year the company did not trade, received no income and incurred no expenditure; hence no profit and loss account is prepared.

The directors received no remuneration for their services to the company (2020 – £nil).

3. Staff costs

The average monthly number of employees (including the director) was 1 (2020 – 1). There were no amounts payable to employees (including the director) during the year ended 31 December 2021 (2020 – £nil).

There are no amounts accruing in a pension scheme in relation to the director's qualifying services to the company (2020 – £nil).
