Opinion

We have audited the financial statements of Dauntsey's School Enterprises Limited for the year ended 31 August 2021 which comprise the Profit and Loss Account, the Balance Sheet and the related notes, including a summary of significant accounting policies. In preparing the financial statements, the directors are responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the company or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. We evaluated management's incentives and opportunities for fraudulent manipulation of the financial statements (including the risk of override of controls), and determined that the principal risks were related to posting inappropriate journal entries to revenue and management bias in accounting estimates. Audit procedures performed by the engagement team included:

- Inspecting correspondence with regulators and tax authorities;
- Discussions with management including consideration of known or suspected instances of non-compliance with laws and regulation and fraud;
- Evaluating management's controls designed to prevent and detect irregularities;
- Identifying and reviewing manual journals, in particular journal entries which shared key risk characteristics; and
- Challenging assumptions and judgements made by management in their critical accounting estimates

NOTES TO THE FINANCIAL STATEMENTS

1. ACCOUNTING POLICIES

General information

Dauntey's School Enterprises Ltd is a private limited company with share capital incorporated in England and Wales. The registered office is Dauntsey's School, High Street, West Lavington, Devizes, Wiltshire SN10 4HE.

Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard 102 Section 1A, applicable in the UK and the Republic of Ireland and the Companies Act 2006.

Turnover

The turnover shown in the profit and loss account represents amounts invoiced during the year in respect of the hiring out of the school's facilities to external organisations.

Financial Instruments

Financial instruments are recognised at transaction value. Financial assets comprise cash at bank and in hand and other debtors. Cash at bank and in hand is defined as all cash held in the bank account and used as working capital. Financial liabilities comprise all creditors and are held at amortised cost.

Distribution of profits

The profits of the company are wholly distributed to Dauntsey's School, the ultimate controlling party, under gift aid.
