Company and its successors in title and assigns and other occupiers of any part or part of the Retained Land shall have the right to divert or vary the positions of any Service Media serving or affecting the Retained Land which are not from time to time owned by or the maintenance responsibility of a statutory supply authority or the Company on giving reasonable prior written notice to the Bank PROVIDED THAT the Company or its said successors in title and assigns first provide a full adequate replacement for such Service Media and that no temporary or permanent interruption of supply shall be caused by such diversion or variation ("the Property") (to the full extent of the Company's interest in the Property or its proceeds of sale.)

- 2. By way of fixed charge:-
 - 1.2 All the plant machinery and fixtures and fittings of the Company now and in the future at the Property.
 - 1.2 All the furniture, furnishings, equipment, tools and other chattels of the Company now and in the future at the Property and not regularly disposed of in the ordinary course of business.
