#### 2. Directors' interests

It was agreed that, in respect of Company's subsidiary undertakings, Campden Securities Limited (Registered number 2826552), Junopart Limited (Registered number 2975806), Speed 5024 Limited (Registered number 3066292) and Virgin Airways Limited (Registered number 2235371), for the financial period ended 31 December 2013 the Company would not require these companies to be subject to audit, and would provide the guarantee required under section 479C of the Act

It was noted that a statement to this effect had been included in note 23 to the Company's financial statements for the period ended 31 December 2013

## 5. <u>Domant Subsidiary Company Accounts Filing Exemption</u>

It was noted that a statement to this effect had been included in note 23 to the Company's financial statements for the period ended 31 December 2013.
