

1.1 Basis of preparation of financial statements

In the opinion of the directors, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Freeth Wastepaper Limited. Suez SA is the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
