DIRECTORS' REPORT FOR THE YEAR ENDED 31 DECEMBER 2001

The directors are pleased to submit their report and the audited financial statements for the year to 31 December 2001.

PRINCIPAL ACTIVITY

The Company acts as a holding company for certain group investments.

REVIEW OF BUSINESS AND FUTURE DEVELOPMENTS

The Company continues to act as a holding company for subsidiary undertakings and is expected to do so for the foreseeable future.

RESULTS AND DIVIDENDS

The profit for the year to 31 December 2001 after taxation amounted to £34,776,382 (2000: £60,523). An interim dividend of £6.52781 per US\$1 ordinary share amounting to £49,422,040 was declared during the year (2000: £Nil). The directors do not recommend the payment of a final dividend (2000: £Nil).

AUDITORS

The Company's auditors, PricewaterhouseCoopers, have indicated their willingness to continue in office. On 23 June 1999 the Company passed an elective resolution to dispense with the obligation to appoint auditors annually.

NOTES TO THE FINANCIAL STATEMENTS

1. ACCOUNTING POLICIES

The financial statements have been prepared under the historical cost convention (as modified by the revaluation of certain fixed assets) and in accordance with applicable accounting standards in the United Kingdom. No cash flow statement is presented since FRS 1 (revised) exempts the Company from the requirement to do so as the consolidated financial statements of ACE Limited include a group cash flow statement. The Company is exempt under section 228 of the Companies Act 1985 from the requirement to prepare consolidated financial statements as it and its subsidiary undertakings are included in the consolidated financial statements of ACE Global Markets Limited.

Interest receivable

Interest receivable is accounted for on an accruals basis.

Interest payable

Interest payable is accounted for on an accruals basis.

Investments

Unlisted investments are stated at the lower of cost and net realisable value.

Foreign currency transactions

Monetary assets and liabilities are translated into sterling at the exchange rates prevailing at the balance sheet date. Transactions in the profit and loss account are translated at the rate of exchange ruling at the dates of the transactions. Share capital dominated in United States dollars is translated into sterling at the historic exchange rate in force when it was issued.

2. TURNOVER

Turnover consists of dividends received from subsidiary companies.

3. DIRECTORS AND EMPLOYEES

The Company has no employees. The directors received no emoluments for their services to the Company (2000: £Nil).

4. OPERATING EXPENSES

The Company's audit fee is borne by ACE London Services Limited.
