The principal activity of the company is that of an intermediate holding company.

NOTES TO THE FINANCIAL STATEMENTS

1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards in the United Kingdom. No cash flow statement is presented since FRS 1 (revised) exempts the company from the requirement to do so as the consolidated financial statements of ACE Limited, the ultimate parent company, include a cash flow statement. The company is exempt under Section 228 of the Companies Act 1985 from the requirement to prepare consolidated financial statements as it and its subsidiary undertakings are included in the consolidated financial statements of ACE Global Markets Limited.

Investments

Investments in group undertakings are stated at the lower of cost and net realisable value.

Foreign currency transactions

Assets and liabilities denominated in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions denominated in foreign currencies are translated into sterling at the rates of exchange ruling on the date of the transaction. Share capital dominated in United States dollars is translated into sterling at the historic exchange rate in force when it was issued.

2. TURNOVER

Turnover consists of dividends received from subsidiary companies.

3. DIRECTORS AND EMPLOYEES

The company has no employees. The directors received no emoluments for their services to the company (2003: £Nil).

4. OPERATING EXPENSES

The company's audit fee is borne by ACE London Services Limited.
